### FROM THE WEST

As I consider the West and its accompanying theme of Strength, I am reminded of an honor I had a number of months ago. I was able to accompany our Most Worshipful Grand Master in a presentation of a 70 yr



Longevity Award to a Brother, I was struck by some interesting thoughts on the subject of the setting Sun. I found it very valuable to consider why we present these longevity awards with an apron specifically designed with the embroidery of a Laurel Wreath, at a time when their Sun is setting in the West.

Upon receipt of our first Lambskin Apron, we hear mention of the Laurel Wreath of Victory. We see it woven into many of our designs and various motif's throughout Masonry, yet it is touched on only briefly in our work. What is this laurel wreath? What is its lineage? Why is it mentioned in this specific piece of our ritual? In short, it is a crown woven of Laurel sprigs and blossoms. The Laurel throughout myth and legend has always been associated with divinity and holiness. Its most notable presentations have anciently been the token reward of great conquest by Generals, Emperors, Kings, Knights and Heroes. It is likely one of the most iconic emblems of the Philosophers of Greece and the Emperors of Rome.

It was most commonly presented however, in the ancient coliseums - a place of atrocious combat and brutality. It was presented to the victor who had persisted through all adversaries, be they beast, circumstance, or the most fearsome foe of all - Man. The presentation of this wreathe indicated that the Blessing of Divinity was upon the

victor. It signified the endowment of Divine Strength -Will and Tenacity, Honor and Fortitude. How often do we take the time to realize that we are, Continued on page 2

each one of us, every day facing the adversaries and challenges in the brutal and atrocious coliseum of earthly Life?

We often hear the word Strength and we think of the iconic flexing arm. We think of the virility and fervency of youth. We think of the energetic enthusiasm of a time when our bodies rarely tired and our faculties served us without flaw. Why then, is our Pillar of Strength located in the West? Why is this column which is so emblematic of Fortitude placed here, where we then state that man's strength decays? Why do we place this particular support in the position where we claim - with "declining strength" our Sun sets? We then give this emblem of the Laurel Wreath-adorned Apron to our Brothers who have finally reached their dwindling days and declining ardor...

Let's consider some of the visceral language of Ecclesiastes - when our windows, which once bore us many a vision of beauty are darkened and opaque, the daughters of music are brought low, when even the grasshopper becomes a burden to the flesh and the strong men which once held us aloft are now bowed and bent...what, in any of this, can we call strength? What, of this decrepit state, is worthy of such an honor as this venerable emblem of victory and power? This, like much of our symbolism, seems at odds with itself. Until we look closely at the words of our work, which have been so carefully selected and positioned. I thought it most poignant that the verbiage specifically states "man's strength" decays. Is man's strength ever an accurate representation of True Strength? Is it even feasible to expect that anything of physical fortitude is comparable with the strength of the Spirit, the Will, the unseen essence of the Blessing of Divinity? It must therefore be one of Divine origin, mustn't it?

It must be one of Herculean measure. It must be a strength worthy of legend, Fortitude and a Will to confront ANY discomfort and even danger at the behest of what we hold as "worthy of investment of the Self," mustn't it? It must be a strength, which is the theme of a most traitorous trek, a journey into a brutal coliseum, or the plight of erecting a monument of Biblical proportions. It must be a Strength much like that of our GM Hiram or our WB George, one which is worth the retelling, over and over and over.

Incidentally, in times past it used to be a more apparent feature of our interview process that a potential Brother not only express a belief in a Supreme Being but also in the immortality of the Soul, which is, of course, so potently portrayed for us in our degree work. And with that, when we consider the declining strength of the body in man's old age, we must then ask - "what strength has he gained?" and "what challenges await us in that undiscovered country of Tomorrow, for us to ply these new strengths?"

Many of us have faced the ferocities of the coliseum of Life, this past year and 2023 isn't proving to be any more docile... Some us have faced those most terrifying moments when we feared our Light might go out. I hope that each of you will take a moment with me and recall the darknesses, the obstructions, and combatants that you have faced this past year. Reflect as we move towards a new Spring, the Strengths that you have gained on this journey; consider the adversaries through whom you have progressed. To what undiscovered country will you now go, with these new powers of Strength, Resolve and Fortitude? What will you now do with your new level of Divine prowess? Remembering that this endowment is predicated upon our relationship with that Providence and our reliance upon it.

May we each apply this growth and its blessing of Divine Strength in service of the Great Architect and our Brothers.

## With many Brothers being Veterans, this educational information on a VA Benefit from one of our Brothers can be of help.

#### VA Aid and Attendance: One of the least known benefits that could positively affect the lives of millions of Americans.

The Aid and Attendance benefit has been in existence for more than 60 years through the Department of Veteran Affairs. Aid and Attendance is a monthly payment to qualifying veterans or their surviving spouses to defray the cost of long-term care for those who need assistance with the daily activities of living such as dressing, bathing, toileting, eating and transferring. It is important to note is that this is a non-service-connected benefit, meaning it does not require the veteran to have been injured or disabled during his or her military service.

For 2023, an unmarried veteran can receive a maximum allowable benefit of \$2,229 each month. An un-remarried surviving spouse's maximum is \$1,432. A veteran and spouse can receive a maximum of \$2,642 a month. We say "maximum" because there are income qualifications that could lower the benefit amount. The good news: A&A is adjusted annually for cost of living increases.

### **Determining Eligibility**

The first step is checking eligibility. First, the veteran must meet requirements for age (65 or older) and service (minimum 90 consecutive days of active duty with at least one day during a recognized period of wartime, with a better-than-dishonorable discharge status). In the case of a surviving spouse, the claimant must have been married to the veteran at the time of death and has not remarried.

<u>Eligible periods of war:</u> World War II: Dec. 7, 1941 – Dec. 31, 1946; Korean conflict: June 27, 1950 – Jan. 31, 1955; Vietnam era: Feb. 28, 1961 – May 7, 1975, for Veterans who served in the Republic of Vietnam during that period. Aug. 5, 1964 – May 7, 1975, for Veterans who served outside the Republic of Vietnam; Persian Gulf War: Aug. 2, 1990, through date to be prescribed by Presidential proclamation or law.

Next, the veteran, or the surviving spouse, must complete a medical assessment to show he or she needs assistance with at least two of the activities of daily living (ADLs). These ADLs are defined as bathing/showering, toileting, dressing, eating, and walking/transferring. The VA also recognizes that a person may function in those areas, but because of dementia or Alzheimer's there is a need for a protective living environment. The medical assessment requires a form filled out by the claimant's regular physician, or forms from an ALF or in-home caregiver, depending on circumstances.

#### **Income and Asset Tests**

Then there are income and asset restrictions. The VA counts the gross income from sources such as, but not limited to, Social Security, pensions, required minimum distributions from IRAs, dividends and interest, annuities and rental income. However, the income is measured against unreimbursed medical expenses (UMEs), such as Medicare Part B premiums and supplemental healthcare premiums.

The asset test is more complicated. The limit for assets in 2023 is \$150,538, but the list of what counts as an asset and what does not gets tricky. For example, the home you live in and its tangible contents do not count. But you are moving into an ALF, so you sell the house. Sticking point: Now those proceeds from the house sale are considered an asset, and maybe that pushes you over the limit. The best way to assess your situation is to speak to a VAaccredited attorney.

### **Moving Forward**

Applying for government benefits can be a daunting task, one that can seem difficult for even the most organized person when facing a blizzard of forms. Many people who attempt to navigate the application process on their own tend to give up after a year or more of problems and denials. In most instances, using an experienced attorney will increase the chances for approval and reduce the wait time.

An experienced attorney can use either Proactive Planning or At-Need Planning to assist you in obtaining this tremendous benefit. In 2018, the Department of Veterans Affairs instituted a threeyear "look-back" period at transfers involving trusts, annuities, gifts, and jointly owned financial accounts. If an asset is transferred, the VA may count it as income or an asset.

That's why it is worthwhile to consult a VAaccredited attorney for proactive planning before you need care.
